COMMUNICATION ON THE TOTAL NUMBER OF VOTING RIGHTS pursuant to Article 85-bis, paragraph 4-bis, of Consob Regulation No. 11971/1999

Florence, April 14, 2026 - Salvatore Ferragamo S.p.A. (Euronext Milan: SFER) (the "Company") announces, pursuant to Article 85-bis, paragraph 4-bis of the Issuers' Regulations, adopted by Consob with resolution No. 11971 of May 14, 1999, the total amount of voting rights at the record date of the Ordinary Shareholders' Meeting convened for April 23, 2026, in a single call, i.e., as of today's date.

In particular, it should be noted that as of today:

- the share capital of the Company, fully subscribed and paid up, is 16,879,000 euros divided into 168,790,000 ordinary shares, without par value; and
- the number of shares with increased voting rights is 108,784,420 (two voting rights per share) out of a total of 168,790,000 shares.

The Company underlines that there has been no change (increase or decrease) with respect to what was disclosed on November 5, 2025.

Pursuant to Article 127-*quinquies*, paragraph 10, of the Legislative Decree No. 58 of 1998, the increase of voting rights is counted for determining the *quorum* of the constitution and deliberations of the Shareholders' Meeting.

Moreover, the Company informs that there are No. 10 additional shares in the Special List of increased voting rights, whose increased voting is in the process of being accrued.
